#### 1. Number of vacancies for student enrolment

## 2. Terms and conditions of application

#### 2.1. Master academic studies

Applicants who meet the requirements in accordance with the general acts of the Faculty and the Law on Higher Education.

## 2.2. Master professional studies

Applicants who meet the requirements in accordance with the general acts of the Faculty and the Law on Higher Education.

### 3. Procedure for application and evaluation of previously completed study programmes

The application for the open call is submitted electronically, through the candidate admission service: <a href="http://prijemni.ftn.uns.ac.rs">http://prijemni.ftn.uns.ac.rs</a>. A candidate has the right to apply for one study programme. If the chosen study programme has modules, a candidate can choose only one study module. After the candidate submits the application, the Registrar's office checks the entered data, assigns the candidate a unique application number and informs the candidate about the success of the application. The application number is the identification number for each candidate during the entire process of application and enrolment.

Submitting more than one application is not allowed. Candidates are advised to complete the application carefully and follow the important deadlines during the open call and enrolment, since late changes and delays will not be considered.

During the open call for enrolment in the master of academic/professional studies, a committee is formed for the purpose of evaluating the previously completed study programme. All candidates who have not completed previous studies at the Faculty of Technical Sciences as well as the candidates who have completed previous studies at the Faculty but who are changing the study programme or study module during the open call are subject to evaluation.

Based on the evaluation of study programmes, the committee determines whether a study programme is appropriate, i.e. whether the candidate can apply for enrolment in master's academic/professional studies. In case of a negative outcome of the evaluation of the previously completed studies, the amount paid for the

evaluation costs will not be returned to the applicant.

## 4. Taking the entrance examination

Candidates who apply for the study programmes Scene Architecture and Design and Scene Architecture and Technique are required to take the entrance exam.

The entrance exam conditions, manner and procedure for taking the exam are determined by the Committee for the evaluation of the given study programme.

Entrance exams will be taken on the Faculty premises, according to the timetable that will be posted on the candidate admission web service: <a href="http://prijemni.ftn.uns.ac.rs">http://prijemni.ftn.uns.ac.rs</a>

A candidate who does not pass the entrance exam cannot enrol.

#### 5. Application schedule

Application for the candidates who have completed the appropriate study programme at the FTN (applies to candidates who do not need to evaluate previously completed studies):

electronic application: from September 16, 2024 until September 30, 2024, at 13:00

application at the Registrar's office: September 27, 2024 and September 30, 2022, from 11:00 to 13:00.

Taking entrance exams:

October 1, 2024, from 09:00 to 13:00.

Publication of evaluation results and preliminary rankings:

October 1, 2024, by 20:00.

**Publication of final rankings:** 

October 3, 2024, by 20:00.

**Enrolment of accepted candidates:** 

October 4, 2024

Candidates who do not appear at the roll call will be considered to have given up enrolment.

Upon completion of enrolment, candidates who are not enrolled should take their documents by October 18, 2024. After that deadline, the documents will not be kept.

## 6. Criteria for determining the order of candidates on the ranking list

Student ranking is done in accordance with the Regulations on student enrolment in study programmes.

A unique ranking list of all candidates is determined with the total number of points obtained according to all criteria.

The right to enrol in a master's degree in academic or professional studies is acquired by a candidate who is ranked within the number of students envisaged for enrolment in the study program. Student status (statefunded or self-financing) is determined based on the number of available places according to the open call.

If two or more candidates have the same number of points, the candidate with a higher grade point average during the study has the advantage.

- Scanned proof of payment of application fees,
- Scanned proof of payment for study programme evaluation,
- Scanned curricula of all previously completed studies (refers to candidates who did not complete their studies at the Faculty of Technical Sciences),
- Scanned certificate of employment at the Faculty of Technical Sciences (applies to candidates employed at FTN)
- CV and portfolio of artistic works (refers to candidates applying to the study programme Scene Architecture and Design),

• CV and portfolio of selected works (refers to candidates applying to the study programme Scene Architecture and Technology).

The candidate can pay the tuition fee in full or in a maximum of two instalments. The first instalment is paid at the time of enrolment and amounts to 50% of the total tuition fee.

The candidate can pay the fees for organizing classes for listening to the supplemental subjects in full or in a maximum of two instalments. The first instalment is paid at the time of enrolment and amounts to 50% of the total cost for supplemental subjects.

## 9. Manner and deadlines for filing a complaint against the established order

The participant in the call may only submit a complaint through the web service for candidate admission: <a href="http://prijemni.ftn.uns.ac.rs">http://prijemni.ftn.uns.ac.rs</a>

A complaint referring to the evaluation results, the number of points achieved on the entrance exam, the regularity of the procedure determined by the call, or the regularity of the entrance exam, are submitted after the publication of the preliminary ranking list, no later than **October 1, 2024 at 12:00 pm.** 

Submission of complaints and their resolution is done within strictly defined time limits. Candidates are cautioned to strictly adhere to the stated deadlines, as late submissions will not be accepted.

Upon receipt of the complaint, it is forwarded for consideration to the appropriate Committee, which determines the proposal of the decision on the complaint made by the Dean. Candidates can see the decision of the Dean on the web service for the admission of candidates.

#### 10. Enrolment of Non-Residents

Foreign citizens can enrol in the first year of the master's academic / professional studies at the Faculty under the same conditions. Candidates - foreign citizens must, when applying for the call, submit verified diplomas of completed undergraduate academic / professional studies.

A foreign citizen pays tuition fees throughout his / her education, unless otherwise stated by an international agreement or a bilateral university agreement.

A foreign citizen can enrol in the study program if he / she provides proof of knowledge of the Serbian language in accordance with the Statute of the University and the Statute of the Faculty, i.e., the knowledge of the language of instructions.

A foreign citizen who has completed previous education abroad may conditionally enrol in the study programme in the event that the procedure for recognition of a foreign school or higher education document has not been completed before the deadline for submitting the application for enrolment, with the proof that the procedure is ongoing. If the request for recognition is rejected or if the recognition of a foreign public document does not give the right to enrol in the study programme to which the person has applied, it will be considered that the conditional enrolment has not been completed.

### 11. Notes

The Faculty of Technical Sciences in Novi Sad provides the students who pay a tuition fee in the academic year 2024/2025 the same conditions and the rights to study as the students whose education is financed from the budget of the Republic of Serbia.

A citizen of the Republic of Serbia who has completed previous education abroad may conditionally enrol in a study programme in the event that the procedure for recognition of a foreign school or higher education document has not been completed before the application deadline, with attached evidence that the procedure is ongoing. If the request for recognition is rejected or if the recognition of a foreign public

document does not give the right to enrol in the study programme to which the person has applied, it will be considered that the conditional enrolment has not been completed.

A student can be financed from the budget only once at the same level of study.

In the event that all the places for enrolment according to the call are not filled, the realization of the enrolment in the second call deadline will begin. The number of vacancies in the study programmes will be announced later.

All other conditions for applying for enrolment, student enrolment, enrolment of foreign students, application deadlines, procedures for forming the ranking list, and complaints procedures are in line with the general and other provisions of the Joint call.
